No modification of this Assignment of Rebate will be effective unless contained in a written agreement dated subsequent to the date of this Assignment of Rebate that expressly references this Assignment of Rebate an terms, and that is signed on behalf of Customer, Assignee, and LIPA by their duly authorized representatives.

Customer and its Assignee agree that if there are arrears on any account that Customer has with LIPA ("Arrears"), LIPA shall apply the amount of any Rebate first to those arrears before remitting the balance, if any, to Customer's Assignee. Customer agrees that LIPA's application of all or a portion of the Rebate to Arrears will not reduce the amount that Customer may owe to its Assignee.
