- (1) This Average Cost of Fuel and Purchased Power, as adjusted to Achieve Targeted Level of Revenues, is set pursuant to the Board of Trustees' February 27, 2003, April 27, 2006, June 22, 2006 and October 25, 2012 resolutions, which provide for recovery of approximately \$103.3 million of targeted revenues for the month of November, 2012
- (2) This Rate is set pursuant to the Board of Trustees' February 27, 2003 and February 10, 2004 resolutions, which provide for amortization of a portion of 2003 excess Fuel and Purchased Power Costs.
- (3) This Rate is set pursuant to the Board of Trustees' February 27, 2003, April 27, 2006 and June 22, 2006 resolutions, which provide for the refund or recovery of overcollections/undercollections. For excess refunds of overcollections relating to 2009 and earlier, this rate provides for the recovery of approximately \$1.3 million for the period November 1, 2012 through December 31, 2012.
- (4) This Rate is set pursuant to the Board of Trustees' February 27, 2003, April 27, 2006 and June 22, 2006 resolutions, which provide for the refund or recovery of overcollections/undercollections. For excess refunds of overcollections relating to 2010 and earlier, this rate provides for the recovery of approximately \$1.5 million for the period November 1, 2012 through December 31, 2012.
- (5) This Rate is set pursuant to the Board of Trustees' February 27, 2003, April 27, 2006 and June 22, 2006 resolutions, which provide for the refund of overcollections. For overcollections relating to 2011 and earlier, this rate provides for the refund of approximately \$5.0 million for the period November 1, 2012 through December 31, 2012.
- (6) This Rate is set pursuant to the Board of Trustees' January 27, 2011 resolution, which provides for the offset of costs that would otherwise have been recovered through the Fuel and Purchased Power Cost Adjustment Rate, resulting from a change in the methodology for measuring Unbilled Revenue. The refund for the period November 1, 2012 through December 31, 2012 is approximately \$5.5 million.
