


#### **AUDITS IN-PROGRESS HIGHLIGHTS**

- PSEG Long Island Electric Expansion Projects Capital Project Estimating
  & Project Management Office (PMO) Playbook
  - O PMO Projects are 50% of LIPA's \$514M T&D Annual Capital Budget
- PSEG Long Island Storm Compliance Crew Guides
  - Effective use of Crew Guides managing Foreign Crews is crucial for major storm response events
- PSEG Long Island Workforce Management Productivity
  - Study of work crew and outside contractor productivity and work management maturity across the work management life cycle
- PSEG Long Island Procurement General Contracting, Facilities Maintenance, and Snow Removal
  - Audit of contractor's bid documents, contracts, purchase orders, and invoices. This audit is a result of employees of another local utility allegedly accepting vendor kickbacks






