# ERM Program Update

---

- ERM provides an annual Board ERM policy update to the F&A Committee. The next annual ERM policy update is scheduled for September and will include the 2023 Risk Profile
- ERM also includes a risk section with each of the Board's annual policy reports, which come to the Board throughout the year (e.g. T&D Operations, Power Supply and Clean Energy)
- The Board also receives issue-specific presentations throughout the year (e.g., Storm Prep, Physical and Cyber Security, etc.)
- Based on your feedback, going forward ERM plans to schedule quarterly formal ERM presentations with the F&A Committee
- Over the past year, ERM has improved the integration of ERM information into internal audits, aligned risks with OSA metrics, and included risks in Project Justification Documents (PJDs) used by management to review Capital Projects
