


#### **Emergency Restoration Plan (ERP)**

- Companywide restoration strategy and playbook
- Includes Incident Command Structure (ICS) and key storm processes and procedures including:
  - Damage Assessment, Dispatch Strategy, Estimated Time of Restoration (ETR) Protocols,
     Customer Communications, FCP, etc.
- Includes supporting plan documentation (e.g., contact lists, protocols)
- ERP closely aligns with that of other New York State electric utilities
- Reviewed and recommendations made by LIPA & NYS Department of Public Service (DPS) adopted:
  - Annual 2025 ERP filing to DPS December 13, 2024
  - Amended Update Filed March 3, 2025
  - Amended ERP Adopted by Commission on April 3, 2025

#### **Emergency Response Implementation Procedures (ERIPs)**

- Supporting procedural documents for conducting restoration operations (e.g., tactical)
- ERIPs align with broader ERP plans and strategies
- Reviewed annually, updated based upon process changes and/or enhancements and submitted to LIPA for approval



### Noteworthy Update to 2025 ERP

**ERP Revamp** – In conjunction with LIPA, PSEG Long Island underwent an extensive review and revamp of the ERP. The document was reformatted to enhance readability and usability. As a result, the ERP is more streamlined and can be used more effectively in restoration response.



- Updated References and nomenclatures in ERP aligned with renaming of key DPS reports (e.g., PSC 4-hour Situation Report & Utility Events Dashboard)
- Reporting and Compliance Items All annual filings now required to be entered through DPS Document and Matter Management (DMM) system (e.g., ERP, Stress Test Reports, LSE certifications)
